AGENDA ITEM #3: Executive Director's Report – Chris Chiles, KYOVA

- Welcome to new Members
 - Mr. Chiles welcomed new members. He gave a brief introduction about KYOVA, and how Region 2 compares to its Ohio and Kentucky counterparts.
- 2020 Census Update
 - Mr. Chiles stated that per the 2020 Census numbers, KYOVA will retain its designated
 Transportation Management Area (TMA) status for the next 10 years. This means KYOVA will continue to receive additional federal dollars, including the suballocated grant funds.
- Safe Streets and Roads for All (SS4A) Action Plan Grant

- o Mr. Chiles informed members this is a federal, competitive grant program. He is pleased to announce KYOVA was awarded an Action Plan Grant for the entire Tri-State.
- Hal Greer Boulevard Corridor Project Update
 - o Mr. Chiles gave a brief overview of The Hal Greer Project. He informed members that progress is on-going and construction is underway.
- Downtown Ashland Complete Street Project Update
 - Mr. Chiles explained that the Project continues moving forward, and construction is expected to begin in 2023. There will be an additional update later in the meeting from Terri Sicking about this project.
- Chesapeake Bypass Project Update
 - o Mr. Chiles explained that funding has been secured to make this project shovel ready, including right-of-way acquisition, design, and environmental documentation. He stated the Draft TRAC list included funding for the first phase of construction, and that Letters of Support are encouraged.
- Update on KYOVA Transportation Studies
 - o Mr. Chiles briefly mentioned the various transportation studies KYOVA staff are currently involved with and directed members to KYOVA's YouTube channel for more information.

The resolutions must be approved so KYOVA can submit the documents to the appropriate agencies for their review and comments. All necessary changes will be made, and the final draft will be presented at the next KYOVA meeting in April.

- o Ms. Wild stated the TIP was updated every two years. She explained this was the first Draft and will go out for Public Review from March 10-April 10, 2023. Chris Chiles reminded the Board this document is fluid and amendments to alter existing projects or add new projects are a part of most Board Meetings.

- o Mr. Davis, General Manager of the Tri-State Transit Authority, gave a Transit update for the Huntington area. He discussed KYOVA's Technical Advisory Committee (TAC) meeting held on Tuesday, February 28, 2023. He described various presentations they discussed. Ralph Kline, Lawrence County, updated members on the Multi-Mobile Transit Parking Deck in downtown Ironton. Randy Wheeler, Ashland, mentioned the need for bus drivers. Mr. Davis briefed members on the need for new employees, ADA accessible bus shelters, and the overall increase in ridership. He described a future study using 5310 funds to examine current and future bus shelters in all three states.
