AGENDA ITEM #4: Executive Director's Report – Chris Chiles, KYOVA

- Safe Streets and Roads for All (SS4A) Action Plan Grant.
 - o Mr. Chiles explained that KYOVA has applied for and received a Safe Streets and Roads for All (SS4A) planning grant with the entire Tri-State as the project scope. He

stated this was a nationwide competition awarded to KYOVA and that no local match was required.

- Ohio DOT/KYOVA Biennial Agreement
 - o Mr. Chiles explained that this is a bi-annual planning agreement between the Ohio Department of Transportation and KYOVA.
- Hal Greer Boulevard Corridor Project Update
 - o Mr. Chiles informed members that progress has begun, with construction being completed next year.
- Downtown Ashland Complete Street Project Update
 - o Mr. Chiles explained to members that this project continues moving forward, design is being finalized, with construction beginning soon.
- Chesapeake Bypass Project Update
 - Mr. Chiles stated all funding has been secured to make this project shovel ready, including right-of-way acquisition, design, and environmental documentation; KYOVA and Lawrence County will continue seeking funding for construction.
- Huntington Welcome Center I-64, Exit 8 Congressionally Directed Spending (CDS) funds
 - o Mr. Chiles gave members a brief overview of the 5th Street Welcome Center. He explained the accessibility of the location being ideal for both West and East bound traffic. He stated \$1.75 million has been awarded to the DOH for design, engineering, and beginning of construction.
