## RESOLUTION APPROVING THE KYOVA REGIONAL TRANSIT SAFETY PERFORMANCE TARGETS FOR THE WEST VIRGINIA COUNTIES OF CABELL AND WAYNE, THE KENTUCKY COUNTIES OF BOYD AND GREENUP, AND THE URBANIZED AREA OF LAWRENCE COUNTY, OHIO

- WHEREAS, KYOVA Interstate Planning Commission has been designated as the Metropolitan Planning Organization (MPO) by the Governors of West Virginia, Kentucky, and Ohio for the Huntington, WV-KY-OH Urbanized Area acting through the West Virginia Division of Highways (WVDOH), the Kentucky Transportation Cabinet (KYTC), and the Ohio Department of Transportation (ODOT), and locally elected officials in the KYOVA region; and
- WHEREAS, federal regulations require Public Safety Providers and State Department of Transportation (DOTs) to establish Safety Performance Targets to address the Safety Performance Measures identified in the National Public Transportation Agency Safety Plan (49 CFR§ 673.11(a)(3); and
- WHEREAS, on July 19, 2018 FTA published the PTASP Final Rule, which is a requirement for recipients of federal funds under the FTA's Urbanized Area Formula Grants (5307) with the rule becoming effective July 19, 2019; and
- WHEREAS, once the Metropolitan Planning Organization (MPOs) receive the Transit Safety Performance Targets from the local Public Transportation Providers they are also required to establish Transit Safety Targets for the MPO Planning area by either adopting the Transit Providers Safety Targets or by setting their own; and
- **WHEREAS,** Public Transportation Providers, State DOTs and MPOs are required to establish seven safety performance targets for the four safety performance measures these seven targets must also set for each "mode" a Public Transportation Provider is responsible for; and
- **WHEREAS,** the modes the Public Transportation Providers in the KYOVA MPO Planning area are responsible to include both fixed bus route and non-fixed bus route service and seven targets must be established and revisited annually for each of these modes; and
- WHEREAS, KYOVA Interstate Planning Commission selected to establish their own Transit Safety Targets based on the information provided by the three transit providers operating within the Huntington, WV-KY-OH Urbanized area; and
- **WHEREAS,** KYOVA Interstate Planning Commission set the following Transit Safety Performance Targets:

WHEREAS, the Policy Committee has analyzed and determined that it will adopt the KYOVA Regional Transit Safety Performance Targets as stated above for the Huntington, WV-KY-OH Transportation Management Area (TMA) for the West Virginia counties of Cabell and Wayne, the Kentucky counties of Boyd and Greenup, and the urbanized portion of Lawrence County, Ohio;

**NOW THEREFORE BE IT RESOLVED** that the KYOVA Interstate Planning Commission does hereby adopt the Regional Transit Safety Performance Targets for the KYOVA planning areas of West Virginia counties of Cabell and Wayne, the Kentucky counties of Boyd and Greenup, and the urbanized portion of Lawrence County, Ohio.
